California Department of Housing and Community Development (HCD) authorized the Housing Authority of the County of Merced funding in the amount of \$221,171.00 to complete miscellaneous improvements at the Atwater Migrant Center. The improvements were recommended in the Physical Needs Assessment that was conducted in June 2013. Improvements will include removing and replacing evaporative coolers (59) and water heaters (62) and crack seal/reseal/restripe the asphalt parking lot/driveway. There are a total of sixty-two (62) units at this Farmworker Center.

California Department of Housing and Community Development (HCD) authorized funding to the Housing Authority of the County of Merced to complete miscellaneous unit modifications at the Los Banos Migrant Center to meet ADA requirements. The work was recommended in the Physical Needs Assessment that was conducted in June 2013. The work will include removing and replacing standard kitchen sinks, modifying the kitchen sink area to comply with ADA requirements and installing new ADA compliant kitchen sinks for three (3) designated handicap units at Los Banos Migrant Center.

HACM issued RFP #2014-05: Sink Replacement – Los Banos Migrant Center. Staff directly solicited at least nine (9) contractors by letter, emails and phone calls.

Bids closed on January 29, 2015 with three (3) proposals submitted:

JSL Construction	Los Banos	\$11,875
2) HANG Construction	Atwater	\$12,100
3) Moss Construction	Chowchilla	\$13,895

The bid received from JSL Construction has been deemed to be the lowest most responsive proposal.

### RECOMMENDATION
